
Background

Social policies have at least three functions in development: First, they have a social / human development function. They provide support to people who do not (yet) benefit from economic development and structural transformation or suffer from individual hardships such as illness or loss of income. Additionally, they help to cushion collective shocks like financial crises, pandemics or some effects of climate change. Without social policies, SDGs 1 and 10 (reduction of income and multidimensional poverty and inequality) cannot be achieved. However, of course, social policies are also crucial for hunger elimination (SDG 2), better health (SDG 3) quality education for all (SDG 4), gender equality (SDG 5), access to drinking water, sanitation and energy (SDGs 6-7) and affordable housing and basic services (SDG 11).

Second, social policies have an economic function: by preventing people from falling into poverty, they strengthen these people's readiness to invest any of their savings in physical or human capital. Without social policies, households tend to hoard savings to be well prepared for future losses or unexpected expenditures. Social policies protect them against the most salient risks and incentivise low-income households in particular to invest into land, machines, health, training and education. In this way, they enable poor and vulnerable households to engage more in productive activities, increasing their productivity and income opportunities. They are thus a key ingredient for making growth pro-poor.

Third, social policies have a political function. They promote the inclusion of citizens, allow them to be more optimistic about the future and encourage them to participate in social life. Thereby, they promote social cohesion: feelings of belonging, solidarity with other citizens, trust in the government and readiness to invest in common goods. Also, social policies are a main duty of governments towards their citizens in sustainable social contracts, while the citizens in turn owe some degree of loyalty and the payment of taxes to the government. Social policies can thus strengthen the acceptability and stability of polity frameworks and reduce the risk that societies and states fall apart when structural transformation leads to significant economic and social upheaval.

As a result, social policies are not only essential for achieving the "social SDGs" (SDGs 1-6 and 10) but also the economic goals (SDGs 8-9) and the goals of peaceful and inclusive societies (SDG 16) and possibly even the environmental goals (SDGs11-15) – hence all aspects of sustainable development.

Research agenda

The overarching question for our research is therefore: What form should social policies take – depending on the respective context – to (i) reduce multidimensional poverty and inequality, (ii) strengthen the willingness of citizens to invest and promote pro-poor growth, (iii) promote social cohesion and (iv) support climate change mitigation and resilience?

In particular, we search for answers on the following sub-ordinate questions:

• How do different social policy instruments interact with each other in different contexts? How should they be combined to form a consistent

overall system? How should they be connected with other policies (taxation, green economic policies, agricultural policies...)?

- How can multidimensional poverty and inequality be adequately measured (in particular in order to reflect adequately conflicts between the different goals of social policies)?
- How do social policies affect social cohesion and social contracts?
- How can social policies make structural transformations and green transitions inclusive?
- How can highly covariate shocks such as pandemics or climate change be dealt with?

With our research we hope to

- fill knowledge gaps on when and how social policies can enhance a virtuous circle of social, economic, and political development,
- inform policy makers and the general public on policy options and their respective effects,
- foster debates on the manifold effects that social policies can have,
- influence political decisions by means of evidence-based research.

Our comparative strength is that we, as a team, combine

- research on social policies with expertise on poverty and inequality measurement, private sector development, financial market expertise, taxation and climate change mitigation and adaptation,
- in-depth case-studies with analyses of development from a broader and multi-goal perspective,
- the use of various quantitative and qualitative research methods and
- extensive experience of working in different world regions.

In addition, our research is embedded in academic and policy networks on national and international levels such as the Global Partnership "Universal Social Protection 2030", the MENA Social Protection Network, the African Economic Research Consortium (AERC) and the EADI Working Group 'Social Protection'. Further research partners are the World Bank, the UNU-World Institute for Development Economics Research, the Kiel Institute for the World Economy and the Universities of Bath, Bonn, Bonn-Rhein-Sieg, Cairo, Hannover, Heidelberg, Manchester, Passau, Rome, Rotterdam and Siegen.
