It wouldn't be expected that differences in income could be reduced in a natural and fast way.

So, what we can do...? (cont.)

In this sense, public policies comply important role to make possible social changes

One of them is the educational policy.

Even though education is recognized as one of the main tools for overcoming poverty, it should also be recognized that, when detached from other public policies, has its impact decreased.

So, what we can do internally?

Despite the educational policy has not in itself be enough to change the living conditions of the poor population, it is an essential condition to make it possible.

So, what we can do internally?

In addition to the educational policy, other important governmental initiatives should be taken: to make progressive tax collection; to expand income transfers, directly and indirectly.

How education can become an indirect transfer of income?

By provisioning universal public education;

But, when the unequals are treated equally, reducing inequalities between them becomes less effective

How education can become an indirect transfer of income?

It should be considered that educational outcomes depend on several factors, including those outside the school
